

**REGULATIONS FOR THE
SCHEDULE OF LICENSING STRUCTURE AND FEES**

For the purposes of Regulations pursuant to the Gambling Act 2016 (No 22 of 2016), the following
Licensing Fee Structure and Applicable License Fees are hereby specified –

Pursuant to **Chapter 4 – Licensing of Local Commercial Gambling Providers of the Gambling Act 2016, No 22 of 2016**, below is the schedule of fees and the licensing structure for the Local Gambling Providers Licenses as required by the Act:

SCHEDULE

Group One Local Gambling Provider’s License A

Gaming Machines only up to 5 machines EC\$2,400.00 per year

Group One Local Gambling Provider’s License B

Gaming Machines only 6 to 12 machines EC\$6,250.00 per year

Group One Local Gambling Provider’s License C

Gaming Machines only 13 to 24 machines EC\$12,500.00 per year

Group One Local Gambling Provider’s License D

Gaming Machines only 25 to 49 machines EC\$25,000.00 per year

Group One Local Gambling Provider’s License E

Gaming Machines only 50 machines and over EC\$45,000.00 per year

Group Two Local Gambling Provider’s License A

Machines and Tables up to 45 machines/up to 4 tables EC\$26,000.00 per year

Group Two Local Gambling Provider’s License B

Machines and Tables 46 to 149 machines/ 5 to 8 tables EC\$52,000.00 per year

Group Two Local Gambling Provider’s License C

Machines and Tables 150 + machines /9 + tables EC\$78,000.00 per year

Local Gambling Provider’s Commercial Lottery Operations License (multiple terminals)
EC\$100,000.00 per year

Pursuant to **Chapter 5 – Licensing of Associates, Agents and Employees of the Gambling Act 2016, No 22 of 2016**, below is the schedule of fees for the Key Persons License as required by the Act:

Key Person License All Licensee profiles EC\$270.00 for three years

Payments Schedule

Are payable to the Authority as prescribed in **Chapter 4, Section 166 (2) (d)** and **Chapter 5, Section 201 and 211 (1) (c)** at the following intervals in advance of the period covered by the Local Gambling Providers License and Key Persons License unless otherwise stated by the Act:

Group One Local Gambling Provider's Licence Fee is Payable byand thereafter

Group Two Local Gambling Provider's License Fee is Payable by August 31, 2017 and thereafter by 31, March annually

Local Gambling Provider's Commercial Lottery Operations License Fee is payable by 31 August 2017 and thereafter by March 31 annually

Key Person License is Payable in Advance and is valid for a period of Three (3) Years from the date of issue

Definitions

Gaming machine means a device that is designated so that:

- (a) It may be used for the purpose of playing a game of chance or a game of mixed chance and skill: and
- (b) It may be operated, wholly or in part:
 - a. By the insertion of a gaming token into the device:
 - b. By the use of gaming machine credits
 - c. By the electronic transfer of credits of gaming tokens to the device: or
 - d. By the use of gaming tokens held, stored or accredited by the device or elsewhere: and
 - e. Because of making a bet on the device, winnings may become payable

Gaming Machine area means a location on licensed premises where a licensee is permitted to install, or has installed, a gaming machine

Gaming token means Eastern Caribbean Dollars, United States Dollars, other currency or a token, credit or other thing that enables a bet to be made on a gaming machine, but does not include a gaming machine credit

Gaming table means a table being used to play a gambling game, or that is available at that time to be used for that purpose;

Gaming table area means a location on licensed premises where a licensee is permitted to install, or has installed, a gaming table;

Local gambling provider's licence means a licence issued under Chapter 4.

Key Employee means a person who—

- (a) *is employed or working in a gambling business in a managerial capacity or who is authorised to make decisions, involving the exercise of his or her discretion, that regulate operations in a gambling business; or*
- (b) *is employed or working in a gambling business in any capacity relating to the following activities—*
 - (i) *the conduct of gaming or betting;*
 - (ii) *is, if the Regulations provide, entitled to hold*

- (A) *a repairer's licence;*
 - (B) *a machine manager's licence;*
 - (C) *a monitoring provider's licence;*
 - (D) *a service contractor's licence;*
- (iii) *the supervision of any of the above activities;*
- (iv) *any other activity relating to operations in the gambling business that is specified by the Authority for the purposes of this definition by notice in writing given to the licensee.*
