Where a licensee is a corporation, no appointment of a director, manager or officer of a licensee shall be made without the prior written approval of the Commission as set out in this application. The Commission shall determine whether the director, manager or officer is a fit and proper person and shall reject or approve the appointment of the director, manager or officer of a licensee within 45 days of the receipt of the request for approval. If the Commission fails to respond in 45 days, the appointment of the director, manager or officer shall be deemed approved.

Alternatively, the form may be printed and completed with the use of a typewriter, or **black ink** and **BLOCK CAPITALS** or typescript.
